APPROVING AND AUTHORIZING THE APPLICATION FOR A DEPARTMENT OF
TRANSPORTATION TIGER GRANT APPLICATION FOR THE SOUTHEAST CONNECTOR
PROJECT BETWEEN SE 14TH STREET AND SE 30TH STREET

WHEREAS, the American Recovery and Reinvestment Act of 2009 made up to \$1.5 billion available for competitive grants for capital investment in surface transportation infrastructure projects that will have a significant impact on the nation, a metropolitan area, or a region; and

WHEREAS, the City of Des Moines is in the process of finalizing the Environmental Impact Statement for the Southeast Connector; and

WHEREAS, the City of Des Moines Engineering Department is preparing a grant application to construct the Southeast Connector from S.E. 14th Street to S.E. 30th Street; and

WHEREAS, the total project cost is estimated to be \$65 million, with the Federal grant amount of \$60 million; and

WHEREAS, the City Engineer recommends that the City Council authorize the Southeast Connector-S.E. 14th Street to S.E. 30th Street application for the Department of Transportation (DOT) Grants for Transportation Investment Generating Economic Recovery (TIGER) discretionary grant provided by the American Recovery and Reinvestment Act of 2009.
